## Statement of Intent

- Where required by legislation, or where significant health, safety or environmental hazards exist, develop, and maintain appropriate emergency and spill response programs.
- Reduce waste production and promote resource efficiency.
- Encourage reduced dependency on single occupancy car travel between sites.
- Reduce the environmental impact of procurement through the formulation and implementation of a sustainable procurement plan.
- Prevent pollution by managing and reducing emissions to air and discharges to water.
- Manage and reduce water consumption where possible.
- Promote environmental awareness among our employees and encourage them to work in an environmentally responsible manner, recycling where possible.


